CREDENTIALS GUIDELINES

In order to be eligible to request clinical privileges for emergency medicine, a practitioner must meet the following minimum threshold criteria:

EDUCATION: MD or DO

MINIMUM FORMAL TRAINING: Applicants must have successfully completed an ACGME/AOA-accredited residency program in emergency medicine, or an approved combined training program in emergency medicine/internal medicine, or an approved residency program in primary care, general surgery, internal medicine, pediatrics, emergency medicine, family practice or any combination of these and/or be board certified in Emergency Medicine by ABEM.

REAPPOINTMENT: Reappointment should be based on unbiased, objective results of care according to the existing quality assurance mechanisms. Applicants must be able to demonstrate that they have maintained competence by showing evidence that they have provided emergency medicine services to at least 100 patients annually over the reappointment cycle.

BOARD CERTIFICATION: The applicant must meet the Medical Staff Bylaws requirements for board certification.

IF YOU MEET THE ABOVE CRITERIA, YOU MAY REQUEST CORE PRIVILEGES IN EMERGENCY MEDICINE.

Assessment, work-up and provision of initial treatment and stabilization of patients who present in the Emergency Department with any illness, injury, condition, or symptom.	-
In addition, the privileges include ability to: perform historical and physician examinations, including ordering and interpreting diagnostic studies; provide services necessary to ameliorate minor illnesses or injuries; stabilize patients who present with major illnesses or injuries; administer appropriate medications; assess patients in order to determine whether more definitive services are necessary; request consultations and technical procedures to be performed by other physicians and qualified consultants/technicians; arrange appropriate follow-up or referral as required; manage the out-of-hospital care of the acutely ill or injured patient.

policy, assessment test, and privilege request form. Reappointment: Will monitor cases for competency.
